## B General information about data processing

### Extent of processing of personal data

No user information is required to visit our pages and read the forums. Even a trial use of our planner is possible without registration. Registration is required to use the scheduler for multiple sessions and to actively use the forums. For this the indication of the E-Mail address is necessary.

For the garden planner the indication of the garden place is of advantage and meaningful, since thereby the system can supply the location-specific data over the vegetables. So that the user can see the last visited page, session-dependent data is stored in a database table on the server.

All other personal information is for the functionality of the Garden planner not relevant. This includes the data about the users (including address and accessibility data), which can be voluntarily entered in the user area by the user but not need.

The users themselves decide whether their profile data remains visible or hidden to other users. All personal information you provide will be treated in accordance with applicable data protection laws.

It will not be passed to third parties.

### SSL encryption

To protect the security of your data during transmission, we use state-of-the-art encryption (SSL) technology over HTTPS. Legal basis for the processing of personal data

Insofar as we obtain the consent of the data subject for processing of personal data, Art. 6 para. 1 lit. a EU General Data Protection Regulation (GDPR) as legal basis. The processing of personal data necessary for the performance of a contract to which the data subject is a party shall be governed by Art. 6 para. 1 lit. b DSGVO as legal basis.

### Data erasure and storage duration

The personal data of the data subject will be deleted or blocked as soon as the purpose of the storage is deleted.

# C The individual data processing in detail

### I .Services and functionalities of the website

## 1. Provision of the website and creation of log files

### a) Description and scope of data processing

Whenever our website is accessed, the calling browser automatically sends data and information from the computer system of the calling computer ("user agent string") without our intervention.

The following data is transmitted here:

- (1) Information about the browser type and version used
- (2) The operating system of the user
- (3) The Internet service provider of the user
- (4) The IP address of the user
- (5) Date and time of access
- (6) Websites from which the system of the user comes to our website.

For our internal evaluations, the calls of our website including the IP addresses are logged and kept in our database for a limited time (currently one month).

### b) Legal basis for data processing

The legal basis for the temporary storage of data and log files is Art. 6 para. 1 lit. f DSGVO.

### c) Purpose of data processing

These data are used by us in the following form:

The IP address is used to determine the approximate location of the user. We need this to give users location-dependent information, such as the weather report. For this purpose, a service of the company MaxMind, Inc. is used. For more information please read below under "MaxMind, Inc."

For our internal evaluations, the calls of our website including the IP addresses are logged and kept in our database for a limited time (currently one month).

Subsequently, anonymized internal statistics, eg on the number of calls depending on the location, are created. The individual logs are then deleted, a backtracking of the users is then no longer possible.

An evaluation of the data for marketing purposes does not take place in this context.

In these purposes, our legitimate interest in data processing by type lies. 6 para. 1 lit. f DSGVO.

### 2. Use of cookies

### a) Description and scope of data processing

Our website uses cookies. Cookies are text files that are stored in the Internet browser or the Internet browser on the user's computer system. When a user visits a website, a cookie may be stored on the user's operating system. This cookie contains a characteristic string that allows the browser to be uniquely identified when the website is reopened.

Cookies are not malicious programs that can do harm to your PC.

Our website only uses cookies during the session so that the server can assign the data sent by the browser to this session (session cookies). Cookies are also used so that a registered user does not have to log in each time the website is started. The use of these cookies can be prevented by unchecking "Remember login".

In the browser you can change the setting of the cookies 'allow and deny'. Please note, however, that the rejection of Cookies the use of gp24.net can make impossible.

Please note: the lack of change of settings of the browser by users is equivalent to the acceptance of the use of cookies by the garden planner gp24.net.

### b) Legal basis for data processing

The legal basis for the processing of personal data using cookies is Article 6 (1) lit. f DSGVO.

### c) Purpose of the data processing

The purpose of using technically necessary cookies is to facilitate the use of websites for users. Some features of our website can not be offered without the use of cookies. For these, it is necessary that the browser is recognized even after a page break.

The user data collected through technically necessary cookies will not be used to create user profiles.

### d) Duration of storage, objection and disposal options

Cookies are stored on the computer of the user and transmitted by this to our site. Therefore, as a user, you have full control over the use of cookies. By changing the settings in your internet browser, you can disable or restrict the transmission of cookies. Already saved cookies can be deleted at any time. This can also be done automatically. If cookies are disabled for our website, it may not be possible to use all the functions of the website to the full.

# 3. Registration

### a) Description and scope of data processing

On our website, we offer users the opportunity to register by providing personal information. The data is entered into an input mask and transmitted to us and stored. A transfer of data to third parties does not take place. The following data is collected during the registration process:

User name, display name and E-mail address.

#### b) Legal basis for data processing

Legal basis for the processing of the data is in the presence of the consent of the user Art. 6 para. 1 lit. a GDPR.

Since the registration serves the fulfillment of a contract of which the user is the contracting party, the additional legal basis for the processing of the data is Art. 6 para. 1 lit. b DSGVO.

### c) Purpose of data processing

User registration is required for the provision of certain content and services on our website.

If you are registered with us, you can access content and services that we offer only to registered users.

There are

- (1) Beetplaner save plans for future use
- (2) Forum Write entries
- (3) Garden Lexicon edit plant information.

To be able to use the bed planner in full and for a longer time, we offer two paid subscriptions (Premium and Club). The payment processing via the service provider PayPal is listed here separately (see under "USE OF PAYMENT SERVICES".

### d) Duration of storage

The data will be deleted as soon as it is no longer necessary for the purpose of its collection.

This is the case for the data collected during the registration process when the registration on our website is canceled or modified.

Premium and Club subscriptions are limited Runtime. They end without any need for notice from users.

Once the subscription has expired, the account on gp24 will be downgraded to a free account. The free account does not have a limited term, because as a registered user you can continue to use the free functions of the garden planner gp24 and gp24market.com.

### e) Opposition and removal possibility

As a user, you always have the option - at any time - to dissolve the registration . You can change the data stored about you at any time .

A complete deletion of the account can under the point "de-register" in the settings of the user account "My Account" - "Manage Account". After the account has been deleted, the user data (profile, access, e-mail address, Beet planner files and subscription entitlements) can not be restored.

### 4. Contact form and e-mail contact

There is no contact form on our website, but you can contact us via the provided e-mail address. In this case (as is generally the case with e-mails), the user's personal data transmitted with the e-mail is saved.

In this context, there is no disclosure of the data to third parties. The data is used exclusively for processing the conversation.

Otherwise, all data protection relevant provisions for e-mail traffic apply.

### 5. Forum & Guestbook

Any mail addresses that have been sent will not be displayed; the published articles will only display the selected username or display name.

### a) Description and scope of data processing

PayPal processes the personal data received from the buyers only to process the payment on the instructions of the buyer.
